The regular meeting of the Ottawa Valley Chapter was held on March 20th at the Prescott Hotel, commencing at 7.00 p.m., with the President, Mr. E.Schoenherr presiding.

After dinner, the business meeting was called to order at 8.15 p.m. The Minutes of the previous meeting were read and accepted as read. The President announced receipt of an invitation from the Montreal Chapter expressing the hope that our Chapter would join them at their annual Golf Spring Tournament to be held at the Eachute Golf & Country Club and to make it the usual joint gathering.
