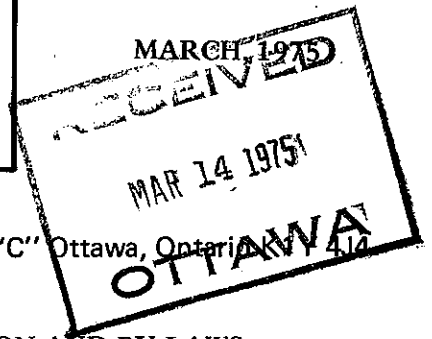

## OUR CONSTITUTION AND BY-LAWS

Our existing chapter by-laws are sadly out-of-date. Your committee on constitution and bylaws, returning to "Law and Order", has studied the situation and decided to the latest ASHRAE model chapter by-laws with revisions to suit our own chapter operation, rather than revise all 87 of the existing 66 Articles in our present constitution.

The procedure for amendment is outlined in our existing by-laws stating that proposed amendments are to be mailed to all members of the chapter not less than 15 days before a 2/3 vote for approval is taken at a regular meeting. The cost of doing this would be in excess of \$200. Your committee proposed that several (6) copies of the proposed by-laws be made available at the March meeting for perusal by interested members, and that any member requesting a copy from the secretary, in writing, would receive one. This proposal was unanimously accepted by your Board of Governors.

Copies will be available at the March meeting and a vote for approval will be taken at the April meeting.
