

ASHRAE 1990 GOLF TOURNAMENT SCHEDULE B

RULES AND REGULATIONS AND COURSE ETIQUETTE

- Golf carts for Tournament play are rented by Tournament players under a separate contract.
- 2. All Tournament players must sign in or be registered before play begins.
- No alcoholic beverages or food of any kind will be permitted to be brought into the Club without obtaining the prior written consent of the Club. No alcoholic beverages are permitted on the course.
- 4. All vehicles shall be parked in the designated parking areas in the main lot. No vehicles shall be left in the fire lanes.
- 5. At the Club's discretion, any player arriving later than tee-off time or improperly attired may be refused the right to play, provided however that the green fees for such a player shall be due and payable and will not be refunded.
- 6. The Club's dress code requires that only the following attire will be permitted:

LADIES:

★Golf slacks (jeans and track pants not acceptable)

★Bermuda shorts (8 1/2" inseam) or skirts not greater than 4" above the knee

★Golf shirts with collars and sleeves

Sockettes or knit dress knee socks (striped sport socks not acceptable)

★Proper golfing footwear

GENTLEMEN:

★Golf slacks (jeans and track pants not acceptable)

★Bermuda shorts (8 1/2" inseam) no greater than 2" above the knee with mandatory knit dress knee socks (striped sport socks not acceptable)

★Golf shirts with collars

★Proper golfing footwear

- 8. Starting time for Tournament play shall be set by the Club. All tee-off times shall be strictly enforced and any player who arrives late for a tee-off time may, at the discretion of the Club be denied play and forfeit green fees. Foursomes are required but may be waived at the Club's discretion. The Club reserves the right to arrange or rearrange draws.
- Royal Canadian Golf Association rules govern all play, except rules as posted.
- On a par 3 hole, players are requested, after play, to wave on group following to permit play.
- 11. To ensure an enjoyable Tournament the Club encourages all players to play not more than a 4 1/2 round.
- 12. Double Par Rule recommended.
